1. Introduction

Global Talents Arena ("GTA", "we", "us", "our") is committed to protecting personal data and respecting the privacy of all users, participants, artists, and visitors.

This Privacy Policy explains how we collect, use, store, share and protect personal data in accordance with the EU General Data Protection Regulation (GDPR) and applicable international data protection laws.

2. Personal Data We Process

- Identification and contact data (e.g., name, stage name/artist name, email address, country of residence).
- Application documents and submitted content.
- Uploaded artistic works (video, audio, image, text).
- Communication data (emails, contact forms).
- Parental or legal guardian consent information (where required).
- Technical data (IP address, browser type, device information, log files).

3. Purposes of Processing

We process personal data for the following purposes:

- Operating and maintaining the Global Talents Arena platform and services.
- Processing applications and managing participation in competitions or events.
- Communicating with users and participants.
- Publishing performances and related content where consent or another legal basis applies.
- Audience interaction, voting and integrity checks (fraud prevention).
- Legal compliance, dispute resolution, and enforcing terms.

- Security, abuse prevention and protection of our systems.

4. Legal Bases (GDPR Art. 6)

Depending on the context, processing is based on:

- Consent (Art. 6(1)(a)).
- Performance of a contract or pre-contractual measures (Art. 6(1)(b)).
- Legal obligation (Art. 6(1)(c)).
- Legitimate interests (Art. 6(1)(f)), such as ensuring platform security and preventing misuse.

5. Cookies and Similar Technologies

We use cookies and similar technologies for website functionality, security, and analytics. You can manage cookie preferences through your browser settings and, where available, our cookie banner/settings. Details are provided in our Cookie Policy.

6. Recipients and Third-Party Services

We may use third-party service providers to operate our website and services (e.g., hosting, analytics, video platforms). Where third parties process data on our behalf, we use appropriate contractual safeguards. Third parties may have their own privacy policies.

- Video and media platforms (e.g., YouTube/Google LLC) if embedded or linked.
- Social media platforms (e.g., Facebook, Instagram, X, TikTok) if you choose to interact with our pages or embedded content.
- Service providers for hosting, email delivery, security and analytics, as needed to operate the platform.

7. International Data Transfers

If personal data is transferred outside the European Economic Area (EEA), we use appropriate safeguards (e.g., adequacy decisions, standard contractual clauses, or comparable mechanisms) where required by law.

8. Data Security

We apply appropriate technical and organisational measures to protect personal data against accidental or unlawful destruction, loss, alteration, unauthorised disclosure or access.

In case of a personal data breach, we will notify affected users and competent authorities where legally required.

9. Data Retention

We store personal data only as long as necessary for the purposes described above, or as required by legal, contractual, or operational obligations. Retention periods may vary depending on the type of data and the applicable requirements.

10. Rights of Data Subjects

Under the GDPR, you may have the right to:



- Access your personal data.
- Rectification of inaccurate data.
- Erasure (right to be forgotten), where applicable.
- Restriction of processing, where applicable.
- Data portability, where applicable.
- Object to processing based on legitimate interests, where applicable.
- Withdraw consent at any time (without affecting the lawfulness of processing before withdrawal).
